



All 14th no's of colleges in Golaghat district eight no's colleges are included in urban category and 6th no's in rural category. Newly provincialized Borpathar, Kamarbandha, Melamora, CNB and Marangi College are not invited NAAC for assessment till now.

Academic Schedule of the B.A./B.Sc./B.Com. programmes in the Semester System shall be administered by the Academic Calendar of the Dibrugarh University published for every academic session. Here 20% marks for internal assessment and 80% marks for End- semester examination in each course during every semester. For internal assessment distribution of marks on the basis of Sessional Examination, Seminar/Group Discussion, Assignment & Attendance. There are no any rigid rules and regulations followed by the teachers on awarding the internal marks. In B.Sc. course DKD College, in B.Com course Golaghat Commerce College and in B.A. course Melamora College produce better performance in different semester examinations. Lack of proper infrastructure facility is found one of the problems of rural colleges of Golaghat districts. Lack of internet facility, separate department/personal room, transportation facility, appropriate class rooms etc. are also found in rural colleges. But there is no difference among the rural and urban colleges of Golaghat Districts on performance. In some cases academic performance in different semester's urban college is better than the rural and some semester's rural colleges are better than urban colleges.

Maximum teachers are not satisfied in present system of assessment and syllabus. No teacher was interested to take viva voice after seminar presentation for internal assessment

The rate of Stagnation is very high in every semester. So that workload of the students is gradually increased in every semester. In B.A, B.Com and B.Sc. 6th semester, average stagnation in Golaghat district was not less than 30%. It means only 70% student can able to complete their all semester regularly.






