Auditors' Report

We have audited the Receipts and Payments Account, Profit and Loss Account and the Balance Sheet of Golaghat Commerce College Employees Thrifts & Credit Co-operative Society Ltd. for the year ended 31st March, 2022. The accounts show true and fair view of state of affairs of the society. At the time of audit, we have examined all the books of accounts, vouchers and documents kept by the Society linked with the accounts. During the course of audit, the Secretary and the Accounts Officer of the Society have provided all the necessary information and explanation.

We hereby report that -

1. The Opening balance of cash in hand and cash at bank as on 1st April, 2021 was Rs. 6,415/- and Rs.3, 97,591/- respectively.
2. The operating result of the society reveals that, earnings for the year is Rs. 7, 34,681/- before charging interest, dividend payable to the members and transfer to students welfare fund.
3. For the year, the proposed rate of interest on deposit of members is 9.5% p.a. and accordingly total interest payable is Rs.6,65,665/-.
4. The net profits for the year after charging interest payable on deposits of members is Rs.69,016/- and an amount of Rs. 10,000 has been transferred to students welfare fund and the remaining amount is used for the payment of dividend @ Rs. 2.05702 per share on 28,690 shares.
5. As on 31st March 2022, total number of members of the society is 76.
6. Regarding the financial position of the society as on 31st March 2022, some of the important liabilities and assets are as follows -
 - (a) The total deposit of the members in the society is Rs. 70, 07,000/-.
 - (b) The share capital of the society amounts to Rs. 2, 86,900/- which is represented by 28,690 numbers of shares of Rs.10/- each.
 - (c) The total loan due as on 31st March, 2022 from the members is Rs. 69, 99,770/-.
 - (d) The amounts receivable from college and members of the society as on 31st March 2022 was Rs. 4,99,226/-.
 - (e) Loan issued by the society during the year was Rs. 43, 85,400/-.
 - (f) For the year, refund of deposit of Rs. 3, 62,000/- (which includes Rs.2,000 received in excess from a member) and refund of share of Rs. 11,000/- was made by the society.

(h) As on 31st March 2022, closing balance of cash in hand is Rs. 1,849/- and
Cash at bank is Rs 5, 61,625/-.

During the audit period we observed that the accounts of the society depicted a true
and fair view of the financial position.

Suggestions

- 1) The auditors observed that the society maintained an average of Rs. 15,000/- (apprx)
during the year in comparison to Rs. 3000/- (apprx) in the previous year. This balance
should be minimized.
- 2) If possible monthly contribution made by the members should be fixed during the year.
Any increase should be done in the beginning of the financial year.
- 3) Cash collected from the members for contribution, loan repayment etc should be deposited
in the bank on the same working day.
- 4) The deposit amount of the members should be taken into consideration before the issue of
loan. For which the Society can think for the amendments.
- 5) A loan application register should be maintained with the following particulars –
 - a) Serial Number
 - b) Application date
 - c) Applicants name
 - d) Amount of loan applied
 - e) Date of loan sanctioned
 - f) Amount of actual loan sanctioned

So that the order of loan can be easily verified
