4. To study the performance of students of the different provincialized colleges of Golaghat district under Dibrugarh University.
5. To study the academic performance of students of rural and urban provincialized colleges.
6. To find out problems of semester system in under-graduate courses of Dibrugarh University and possible solution in order to rectify the shortcoming.

12. WHETHER OBJECTIVES WERE ACHIEVED:

Objective No-1: Dibrugarh University is a leading higher educational institution in upper Assam. In under-graduate courses, university conduct external and internal assessment on the basis of "Examination Ordinance 1972" and "Semester Regulation 2010".

Objective No-2: There was no different procedure found in awarding the internal marks in the provincialized colleges of Golaghat district. But weightage of the internal assessment were given according to the teachers and departments of the colleges.

Objective No-3: The opinion of the teachers and members of the Student Union of the colleges was different on internal and external assessment system.

Objective No-4: In this study I was trying to assess the performance of different provincialize colleges of Golaghat district on the basis of academic year 2014-15, 2015-16, 2016-17 & 2017-18. In this analysis I was found that in B.Sc. course DKD College, in B.Com course Golaghat Commerce College and in B.A. course Melamora College show better performance in different semester examinations.

Objective No-5: Students pass percentage of rural and urban provincialized colleges was difference in different semesters.

Objective No-6: I try to find out the opinion of the teachers and members of the students union of different colleges of Golaghat district about semester system. I also try to find out the problems of semester system in under-graduate courses of Dibrugarh University and try to provide possible solutions in order to rectify the shortcomings.

1. Knowledge about the colleges of Golaghat districts.
2. Understanding on under-graduate systems of Dibrugarh University
3. Assessment system of Dibrugarh University.

14. SUMMARY OF THE FINDINGS:

There are 17th no's of undergraduate college in Golaghat district. Among them 14th no's are provincialize by the Government of Assam. Among them Commerce stream of Sarupathar College, Arts Stream of Golaghat Commerce College, and full-fledged college of Borpathar, Kamarbandha, Melamora, CNB & Marangi College were provincialize in the year 2013. All 14th no's of colleges in Golaghat district eight no's colleges are included in urban category and 6th no's in rural category. Newly provincialized Borpathar, Kamarbandha, Melamora, CNB and Marangi College are not invited NAAC for assessment till now.

Academic Schedule of the B.A./B.Sc./B.Com. programmes in the Semester System shall be administered by the Academic Calendar of the Dibrugarh University published for every academic session. Here 20% marks for internal assessment and 80% marks for End- semester examination in each course during every semester.

For internal assessment distribution of marks on the basis of Sessional Examination, Seminar/Group Discussion, Assignment & Attendance. There are no any rigid rules and regulations followed by the teachers on awarding the internal marks. In B.Sc. course DKD College, in B.Com course Golaghat Commerce College and in B.A. course Melamora College produce better performance in different semester examinations. Lack of proper infrastructure facility is found one of the problems of rural colleges of Golaghat districts. Lack of internet facility, separate department/personal room, transportation facility, appropriate class rooms etc. are also found in rural colleges. But there is no difference among the rural and urban colleges of Golaghat Districts on performance. In some cases academic performance in different semester's urban college is better than the rural and some semester's rural colleges are better than urban colleges.

Maximum teachers are not satisfied in present system of assessment and syllabus. No teacher was interested to take viva voice after seminar presentation for internal assessment

The rate of Stagnation is very high in every semester. So that workload of the students is gradually increased in every semester. In B.A, B.Com and B.Sc. 6th semester, average stagnation in Golaghat district was not less than 30%.It means only 70% student can able to complete their all semester regularly.

Among the all semesters result it was found that students achievement of Melamora College is exceptionally high than the other colleges of Golaghat district.

15. CONTRIBUTION TO THE SOCIETY:

The purpose of higher education is to prepare the students for good citizenship in a democratic society. Here try to improve students critical thinking, capacity to evaluate decisions, develop social responsibilities, cultivate and appreciation of aesthetical and ethical values etc. in socio-cultural prospective. Contributions to the society through the present study are:-

1. Society can be able to know about the procedure of semester system in under-graduate level.
2. Society will be able to know existing assessment procedures in the semester system as well as its different problems.
3. This study identifies the deficiencies and flaws present in the semester system, and provide their solutions.
4. This study finds out problems of rural higher education system in Golaghat district and its solution.
5. Parents can be able to select better institutions among the 14th no's of provincialisation colleges for their children.




