- (i) The First Party shall, at its sole discretion, send intimation to the Second Party to collect the E-Waste either at a specified interval of time or whenever specified quantity of E-Waste is generated.
- Iii) The Second Party hereby agrees that it shall pick the E-Waste from the college premises as per shared list by the First party without any cost and shall ensure that proper documentation of the same is done as required under the applicable laws / rules/ regulations.
- iv) The Second Party agrees that when the E-Waste comprises of Hard Disk(s), it shall be destroyed by the Second Party and the Second Party shall share photographs of the destroyed Hard Disk(s) as evidence.
- v) The Second party hereby undertakes that it shall follow proper ISO guideline and /or any other applicable guidelines in the process of disposing the E-Waste.
- Vi) The Second Party hereby undertakes the responsibility of safe & secured storage, segregation, recycling, extraction, destruction, disposal of the E-waste as per the guidelines of the Central and relevant State Pollution control Board and the Second Party shall issue a disposal certificate to the First Party within 45 days from the date of collection of E-Waste from the premises of the said college.
- vii) The duration of the agreement shall be 1year from the date hereof and it may be renewed by the parties with mutual consent.
