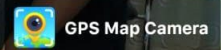

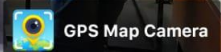

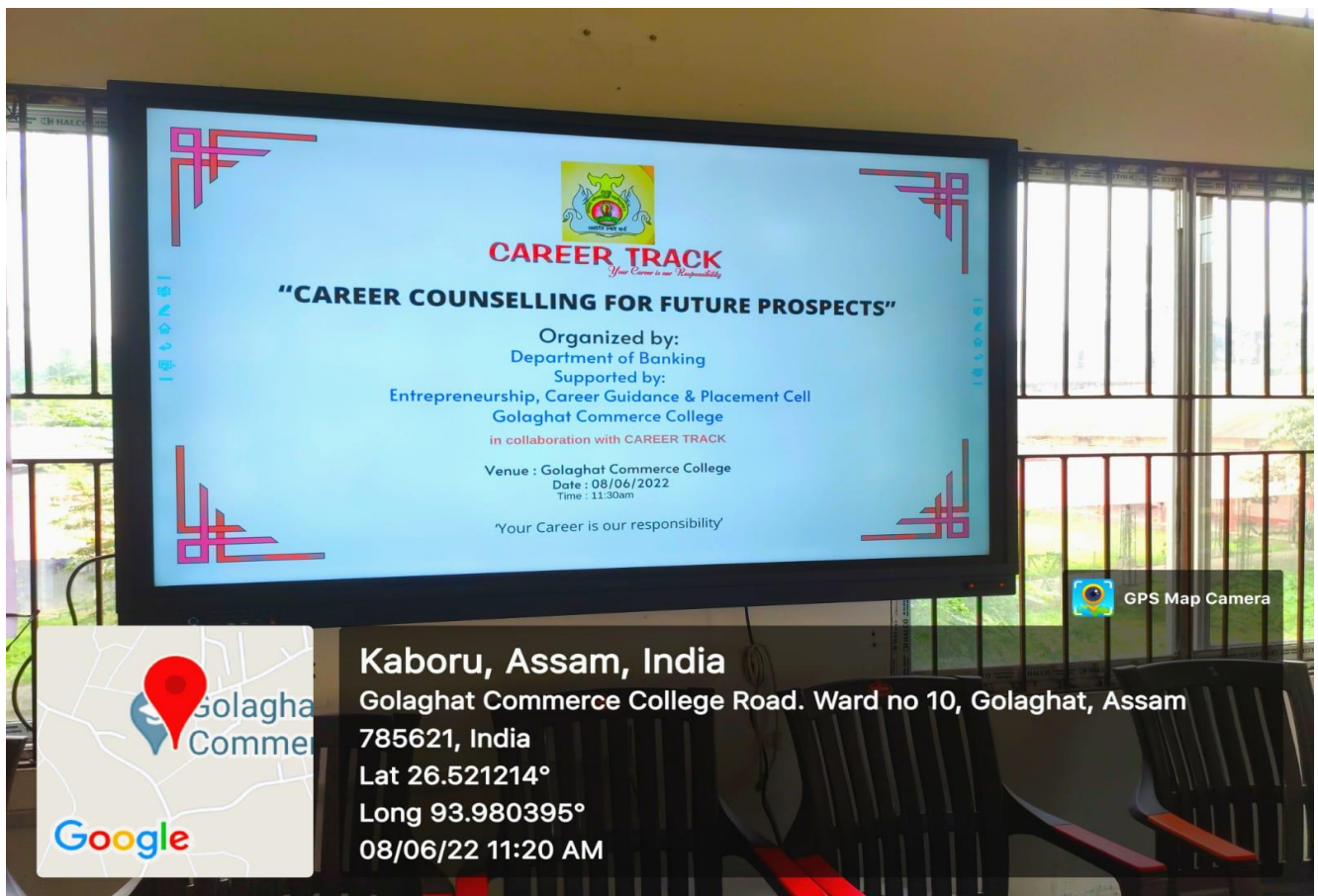

MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING (MOU) is executed on this 8th day of June, 2022 between CAREER TRACK, Tarajan, Jorhat hereinafter referred to as the party of the First Part and the DEPARTMENT OF BANKING, Golaghat Commerce College, Jyoti Nagar Golaghat, Assam, referred to as the party of the Second Part.

This Memorandum of Understanding (MOU) is a service agreement to conduct/ provide training programme/ workshop to students for competitive exams between CAREER TRACK, JORHAT and DEPARTMENT OF BANKING GOLAGHAT COMMERCE COLLEGE, GOLAGHAT.

1. 


